#### REPORT OF THE ACCOUNTANT

In accordance with instructions given, I have carried out an independent examination of the accounting records shown to me and can confirm that an accurate record of the financial activity of the Association has been kept. From these records, and other information supplied, I have prepared accounts on a receipts and payments basis for the year ended 31st March 2013.

The Association received a donation of £408.14 from coffee mornings held in the year which was given with unrestricted use. The sale of a floor cleaner realised £200.00 which was banked.

The Association made a donation of £600.00 to the Youth Forum. This was combined with a donation of £100.00, received in the previous year from the family of a patron of the club who had died, to purchase a bench for the play park

The Association has two bank accounts, both with CAF Bank (Charities Aid Foundation). The two accounts have combined funds of £28122.38

The Association has assets in the form of equipment and furnishings which have a cost value of £14089.00. This value comprises of both actual and estimated cost. The assets are a mixture of purchased and donated items.

The Association has liabilities of £2272.86 made up of £657.75 customer deposits held, £1480.11 owed to suppliers and £135.00 accountancy fees
